By a motion of Commissioner Castlen, seconded by Commissioner Wathen, the court considered approval of all Claims for all Departments.

Without further discussion, Judge/Executive Mattingly called for a vote on the motion. All members of the court voted in favor; motion passed.

By a motion of Commissioner Koger, seconded by Commissioner Wathen, the court considered for approval **Resolution No. 02-2016** - Establishing a Section 3 Affirmative Action Plan

He clarified an inaccurate statement in the messenger-Inquirer where it was indicated that the Friendly Village treatment plant was less important than the Cedar Hills plant. He said that both plants are equally important, but the Cedar Hills plant is having a current negative effect on neighborhood homes and may be in need of more urgent attention than the Friendly Village plant and wanted to ensure all interested of their equality.
